The Management of the Company is also responsible for ensuring compliance in accordance with the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended from time to time relating to voting done by means of postal ballot through remote e-voting facility on the resolution as set out in the Notice.

In accordance with the MCA Circulars, the Company has sent the Notice only through electronic mode. Accordingly, the communication of the' Assent' and 'Dissent' of the members took place through the remote e-voting facility only.

Responsibility as a Scrutinizer

My responsibility as a Scrutinizer for the postal ballot conducted through remote e-voting facility is to ensure that the voting process is conducted in a fair and transparent manner and is restricted/ limited to issuance of the Scrutinizers' Report on the votes cast as "Assent" or "Dissent" / "For" or "Against" for the Special Resolution stated in the Notice and ascertaining the requisite majority thereon, based on the reports generated from the electronic voting facility provided by MUFG Intime India Private Limited, Registrar and Share Transfer Agents (RTA) of the Company providing remote e-voting facility.

The Notice along with Explanatory Statement under Section 102 of the Act, was sent by the Company only through electronic mode to those members whose email addresses were registered with the Company/ Depository Participant(s) as on Tuesday, 8th April, 2025 ("cut-off date"). Further, the Company vide the Postal Ballot Notice dated 10th April, 2025 had also requested its members to register their email addresses with the Registrar and Share Transfer Agent of the Company. The members holding shares as on the cut-off date were entitled to vote on the proposed resolution as set out in the Notice.

I submit my report as under:

- i. The Company completed the dispatch of Notice (for the process of remote e-voting), only through electronic mode to members whose e-mail addresses were registered with the Company/ Depository Participant(s) and whose name(s) appeared in the Register of Members/ Register of Beneficial Owners as on the cut-off date.
- ii. An advertisement regarding Notice/ remote e-voting was published in the newspapers i.e., Business line and The Hindu (Tamil Edition) on 12th April, 2025.
- iii. The members have casted their votes through remote e-voting facility on the designated website URL (https://instavote.linkintime.co.in/)
- iv. The remote e-voting for postal ballot process commenced on 11th April, 2025 (9.00 A.M. IST) and ended on, 10th May, 2025 (5.00 P.M. IST).

- v. All the votes received up to 5:00 P.M. on 10th May, 2025, being the last date and time fixed by the Company for remote e-voting, were considered for my scrutiny. The remote e-voting facility was disabled by '**INSTA VOTE' immediately** thereafter.
